Collection and Use of Personal Data by Lions Clubs International

Lions Club International recognizes the importance of protecting the private information of our members. LCI collects personal information about Lions Club members to facilitate communications with and between our members. This information is to be used solely to further its purposes including that "to unite the clubs in bonds of friendship, good fellowship, and mutual understanding" and to conduct its necessary operational activities including:

- Dues and other billings
- Distribution of The Lion magazine and membership/officer information updates.
- Compilation of membership profiles and trends to support membership growth, extension and retention programs.
- Convention and meeting planning.
- Contact information for Lion leaders, including past and present International Officers, Directors, and Board Appointees, Multiple District Council Chairpersons, and Council of Governors, District and Vice-District Governors, and Club Officers.
- Furtherance of Public Relations activities and Cooperative Alliances
- Support of Lions Club International Foundation and other adopted service programs.
- Special advertising, non-dues revenue programs or other purposes in accordance with the Purposes and Objectives as determined by the International Board of Directors.
- Disclosure of information as required by law or that is pertinent to judicial or governmental investigations.

Lions Clubs International protects personal information by using password-protected areas and by restricting access to such information. It is important that you protect your password.

Any payment information collected is protected by software during transmission, which encrypts all of your personal information so that it can be safeguarded over internet channels. We reveal only a limited commercial mailing list and Lions Club members should ensure it is not used for that purpose.

Privacy Recommendations for Lions Clubs, Districts, Multiple Districts and Foundations.

Your Lions Club, District, Multiple District and/or Foundation should consider your privacy practices and follow similar guidelines when using the personal information of members, donors, recipients of your humanitarian assistance, or that of other individuals obtained in the course of conducting your activities. You should consider obtaining written permission before disclosing any personal information including names, addresses, email addresses, telephone numbers, medical information, financial information, etc. You should also be cautious when posting any personal information on the internet or sharing email addresses with third parties. Please be aware that LOCAL LAWS MAY GOVERN THIS ISSUE and these laws vary widely from country to country, so you should seek advise from a local expert for more information before any personal information is used.

- **To Coordinate** the activities and standardize the administration of Lions clubs.
- **To Create** and foster a spirit of understanding among the peoples of the world.
- **To Promote** the principles of good government and good citizenship.
- **To Take** an active interest in the civic, cultural, social, and moral welfare of the community
- **To Unite** the clubs in the bonds of friendship, good fellowship, and mutual understanding.
- **To Provide** a forum for the open discussion of all matters of public interest; provided, however, that partisan politics and sectarian religion shall not be debated by club members.
- **To Encourage** service-minded people to serve their community without personal financial reward, and to encourage efficiency and promote high ethical standards in commerce, industry, professions, public works and private endeavors.

Lions Code of Ethics

- **To Show** my faith in my vocation by industrious application to the end that I may merit a reputation for quality of service.
- **To Seek** success and to demand all fair remuneration or profit as my just due, but to accept no profit or success at the price of my own self-respect lost because of unfair advantage taken or because of questionable acts on my part.
- **To Remember** that in building up my business it is not necessary to tear down another's; to be loyal to my clients or customers and true to myself.
- **Whenever** a doubt arises as to the right or ethics of my position or action towards others, to resolve such doubt against myself.
- **To Hold** friendship as an end and not a means. To hold that true friendship exists not on account of the service performed by one another, but that true friendship demands nothing but accepts service in the spirit in which it is given.
- **Always** to bear in mind my obligations as a citizen to my nation, my state, and my community, as to give them my unswerving loyalty in word, act, and deed. To give then freely of my time, labor, and means.
- **To Aid** others by giving my sympathy to those in distress, my aid to the weak, and my substance to the needy.
- **To be Careful** with my criticism and liberal with my praise; to build up and not destroy.

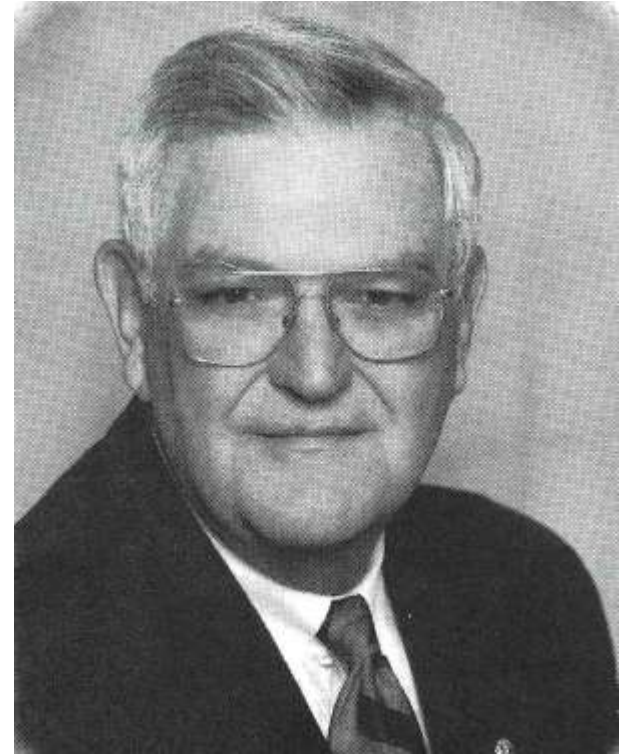

Club President's Excellence Award Requirements

The Application should be completed by the Club Secretary, approved by the proper District officers. The completed form must be mailed to the International Office within thirty (30) days following the International Convention.

1. The Club complied with the Association Constitutions and By-Laws and policies of the International Board of Directors and refrain from any action encouraging unauthorized use of the name , good will, emblem, the marks "Lions Club", Lions International" or "Lions Clubs International", and other insignias of this Association.
2. The Club shall have no unpaid balances of over US \$50 owing to the International office by March 31 of the fiscal year.
3. The Club must show a net increase in Club membership for the fiscal year. Deaths and transfers are not counted.
4. An accounting must be made of all Monthly Membership Reports (MMR's).
5. In order to qualify for the award, the Club President must certify that he/she has properly inducted and Indoctrinated all new members and involved all new members by assignments to a working activity or service committee.

From the following assignments six (6) must be completed.

1. all other reports required by the International Office and/or Single Sub or Multiple District of which the President's Club is a part, must have been filed on time.
2. During the term as President, he or she has sponsored one new Lion into the Club who was inducted during the fiscal year.
3. The Club must have conducted at least one major Service Activity, which shall have been reported on the Club's MMR (Monthly Membership Report). Organization of a Leo or Lioness Club can be regarded as a major Service Activity.
4. The Club must have conducted one major Fund Raising project with substantial Membership participation, which shall have been reported on the Club's Monthly Membership Report (MMR).

5. The PU-101 forms must have been submitted to the International Office before May 31.

6. Club Presidents must have attended at least two Zone Advisory Committee Meetings in person and must have been in attendance at, or shall have been represented at all other such meetings held in his/her Zone, and reported on the Monthly Membership Report (MMR).

7. The Club President must have attended a Single, Sub or Multiple District Convention or Conference or International Convention preceding or during his/her term of office.

8. The Club President must have attended a Club Officers Training Workshop or School conducted by the District.

9. The Club President must organize at least one Lions Club during his/her term of office.

In order to be eligible for the “Club President’s Excellence Award”, the President must have been recommended by the Zone or Region Chairperson to the District Governor and the District Governor must have certified the President as having met all the requirements thereof. Such certification must be mailed to the International office within 30 days after the close of the International Convention.

In order to qualify for the award, the Club President must certify that all new members have been properly inducted and involved by assignment to a working Service Activity Committee.

100 % Club Secretary District Award

The Application should be completed by the Club Secretary, approved by the proper District officers. The completed form must be mailed to the International Office within thirty (30) days following the International Convention.

1. Monthly Membership Reports (MMR's) mailed to the District Governor and post marked no later than the third (3rd) of the month. This requirement begins with the August MMR Report. (Example: August MMR Report must be postmarked prior to September 4.)
2. Must have sponsored one (1) new member during the year or the Club must meet the District Governor’s membership goals.
3. All accounts paid when due to Lions International and District and reported on MMR Report for the month in which paid.
4. Attend all three (3) Zone Meetings. Authorized substitute may attend one (1) Zone Meeting in your place.
5. Attend all Cabinet Meetings, Mid-Winter Conference, and the District Convention. An authorized substitute may attend one (1).
6. File your Club IRS 990 on or before October 31, and report same on the October MMR Report.
7. Complete and mail PU-101 forms to International and District prior to April 15th.
8. Be recommended for the award by your Club President and your Zone Chairman by letter to the Cabinet Secretary.
