



Lions District 2-A2 2020 Young Women's Scholarship Pageant



The District 2-A2 International Association of Lions Clubs will conduct a competition for the title of "Lions District 2-A2 Queen 2019-2020" to be held at the Inn of the Hill Hotel and Conference Center in Kerrville, Texas on Saturday, April 4, 2020.

General Information

The tentative schedule for April 4, 2020 is as follows:

9:00–11:00 am	Judge's Interview
11:00 am–12:00 pm	Pageant Practice
12:00 Noon	Youth Scholarship Luncheon and Pageant

The contest will begin promptly at 9:00 AM. Contestants need to arrive in the Main Lobby of the Inn of the Hills Hotel on Saturday, April 4, 2020, by 8:30 a.m.

The contestants should be dressed in business casual for the interview, and remember, this is your first impression before the judges and first impressions can make a difference. The contestants are asked to wear formal attire and will be presented individually at the Youth Luncheon Saturday at 12:00 noon. There will be a room available for changing for those contestants who will not have a room in the hotel.

The contestants will draw numbers to create the order of appearance before the judges for the interview and the evening pageant.

There will not be a fee charged but the contestants will be selling ads for the convention program book and selling will be part of the overall scoring for the contestants.

Pageant Scoring

The pageant scoring will consist of:

1. A personal interview with the judges.
2. Charm and Poise.
3. Advertisement sales.
4. Beauty and Grace.

The contestants will be interviewed individually by the judges. The interview portion of the contest is a "closed session." Only the individual contestant and the judges will be in the room. The interview questions will consist of background, ambitions, studies, social and community involvement and character. Also a factor will be the applicant's mental alertness, personality, sense of values, clarity of expressions, knowledge and perception, personal appearance, human relations, activities and honors. Each contestant's Charm and Poise will also be judged during their interview.

The category of selling ads will have the points determined before April 4, 2020. Points will be determined according to both the number and the total value of the ads sold by the contestant and submitted by **March 15, 2020**. The highest seller will receive 100 points, the next highest will receive 95 points and thereafter reducing by five (5) points.

Awards

1. The 1st place winner will receive a \$1,000.00 scholarship.
2. The 2nd place winner will receive a \$500.00 scholarship.
3. To collect the scholarship award, the Contestant must complete the following process:
 - a) Contestant must complete and submit the Scholarship Request Form and proof of registration information from a university, college, junior college or vocational school.

4. Payment will be made out to the contestant **and** the designated school and sent to the contestant to take to the school.
5. The scholarship awards must be collected no later than two years following the recipient's graduation from high school.

Contestant Eligibility

1. Each contestant must be a junior or senior in high school or comparable educational program, located in Texas at the time of the District 2-A2 contest.
2. A false statement on the entry application or associated documents and late entry applications are causes for disqualification of the Contestant.
3. A Lions Club may sponsor no more than one Contestant in each contest by submitting a completed entry application (containing all requested signatures), associated documents to the Pageant Coordinator prior to the entry deadline.
4. Contestants shall not have been married, had a marriage annulled, co-habited with a person of the opposite sex who is unrelated to the Contestant.
5. Contestant cannot be a parent or become a parent during reign as Lions District 2-A2 Queen.
6. Contestant must be of good moral character and values.
7. Contestant must not have been convicted of any criminal offense and/or there may not be any criminal charges presently pending against them. Any infractions will constitute as an automatic disqualification.

Responsibilities of the Contestant

1. The District 2-A2 Youth Contests are largely funded through the sale of ads in the Conference Souvenir Program. A part of each contestant's score will be based on both the number and the total value of the ads sold by the contestant.
2. Each Contestant shall be required to sell a **minimum of three (3) ads to local businesses** in addition to selling ads to Sponsoring Lions club, parents and relatives.
3. Each Contestant shall be required to submit the following to their sponsoring Lions Club by **March 15, 2020**:
 - a) Ad Agreements, camera ready ad copy and two (2) 4x6 or 5x7 photos of the Contestant (head and shoulders close up) **Electronic submissions are preferred in PDF format.**
 - b) Ad payments for all sales ads are to be included in the packet to the Sponsoring Lions club. All checks made payable to Lions District 2-A2. **Be sure to put contestant name and the name of the contest on the memo line of each check to insure credit for the sale is included in the correct contest.**
 - c) The two page Young Women's Scholarship Pageant Application is to be included in the packet sent to the Sponsoring Lions club.
4. Attend the District Convention at the Inn of the Hills Hotel and Conference Center in Kerrville, Texas on **Saturday April 4, 2020**. All contestants are to report to the Lobby inside the main entrance of the Hotel **by 8:30 a.m.** Judges' interviews will be conducted between 9:00 – 11:30 am.
5. All contestants are expected to attend the District 2-A2 Convention Youth Awards Luncheon at the Inn of the Hills Hotel on Saturday, April 4, 2020 beginning at 12:00 noon.

Responsibilities of the Sponsoring Lions Club

1. The Sponsoring Lions Club must make sure the two page Young Women's Pageant Application with all required signatures, and are sent to the District 2-A2 Young Women's Scholarship Pageant Coordinator to be received no later than **March 15, 2020. No Exceptions.**
2. The Sponsoring Lions Club must collect the Ad Agreements, camera ready ads, ad payments and Contestant photos from their contestant and submit to Lion Abel Martinez **before the deadline of March 15, 2020. No Exceptions.**
 - (Electronic submissions are preferred in PDF format for the Ad Agreements, camera ready ads and contestant photos which are to be emailed to Lion Abel Martinez at amartinez430@yahoo.com by **March 15, 2020.**
 - Ad payments are to be mailed to Lion Abel Martinez, 412 S. San Manuel, San Antonio, Texas 78237 and received by **March 15, 2020.**
3. The club is responsible for making sure the contestant arrives at the District Convention at the Inn of the Hills Hotel and Conference Center in Kerrville, Texas on Saturday, **April 4, 2020 by 8:30 a.m.**
4. The Sponsoring club must insure that the contestant is accompanied at the Convention by a parent/guardian or designated chaperone from the club.
5. The club is also responsible for paying for the meals for the contestant (and the parent(s) if they are in attendance) and one night's lodging (if applicable) before the Convention.
